Moldova vACC Constitution

## 1 Objective

The purpose of Moldova vACC is to provide regular, high quality ATC in The Republic of Moldova on the VATSIM Network. Moldova vACC shall strive to be the most professional and dedicated vACC on the VATSIM Network, providing high quality ATC Training and assisting pilots on VATSIM. Moldova vACC aims for realism whilst still acknowledging that VATSIM is a virtual network and we aim to help those whom are new and "learning their way" so to say.

## 2 Definitions

### 2.1 vACC Director

Head of Moldova vACC's staff must have a rating of C1 or higher in VATSIM and be approved by the Director of VATEUD and VATRUS when appointed.

### 2.2 Staff

Members working with the management of Moldova vACC, must have been a member of Moldova vACC for at least one month, have a rating of S3 or higher in VATSIM, and be approved by the vACC Director when appointed. The Training Director must have a rating of C1 or higher in VATSIM. All Official Staff Members have voting rights within Moldova vACC.

### 2.3 Non - Executive Staff

Non - Executive staff members are defined as members working with the management of Moldova vACC subordinated any official staff member. The member must have been a member of Moldova vACC for at least one month and have a rating of S2 or higher in VATSIM.

### 3 Relations, responsibility and ownership

Moldova vACC is part of the VATSIM Organization, VATSIM.net, responsible for the area covered by the following Flight Information Region (FIR): Chisinau FIR (LUUU). Moldova vACC is currently organized in the VATEUD Division. Moldova vACC is and always will be a non-monetary organization with no financial income. Membership is free. Moldova vACC is owned jointly by its active ATC members, under the directional responsibility of the vACC Director.

## 4 Membership

### 4.1 Membership Application

An application for membership must be completed using the online forms provided on the Moldova vACC website. An application must include all information requested on the form; particularly a member's full

name and VATSIM ID, as well as a short statement detailing why they would like to become a member of the vACC, is required for enrolment to Moldova vACC. The decision to accept an application is made by the Director or Deputy Director whose decision will be final.

### 4.2 Full Membership

A full member is defined as a VATSIM membership who's home vACC is Moldova vACC. This allows this member to exercise his/her rights to control any ATC position within the Chisinau FIR providing appropriate ATC validations have been issued by an ATC mentor according to VATSIM Global Ratings Policy v2.0. A full member will have no restrictions on the amount of time they can control within the Chisinau FIR.

#### 4.3 Visiting Controller Membership

Visiting Controllers are VATSIM members whom are not home members of Moldova vACC, but to whom particular rights are granted by decision of the Director or Deputy Director.

Visiting Controller status may be withdrawn partly or completely by the vACC Director at any time. The decision to withdraw Visiting Controller status will be announced to the affected member. It is incontestable. Visiting Controllers will only be considered for Visiting Controller Membership if they hold a permanent rating of Senior Student (S3), in their home vACC. The applicant must have consolidated their rating by controlling for 50 hours on their current rating in their home vACC on an appropriate position for their rating. For example a Controller (C1) applicant must have controlled for 50 hours on a XXXX\_CTR position in their home vACC where they hold Full Membership. A list of approved Visiting Members is provided on the vACC website.

#### 4.4 Termination of Membership

VATSIM membership is terminated upon the receipt of written resignation addressed to the VATSIM VP Membership, or as soon as a member's VATSIM membership has been terminated due to gross violation of the VATSIM Code of Conduct or Code of Regulations. A person's membership of Moldova vACC may be terminated by unanimous decision of the Staff Board, providing that sufficient evidence has been provided against the member concerned. Even though the members Moldova vACC membership has been terminated, this will not affect the person's membership of VATSIM. Moldova vACC does not hold the rights to ban or remove a members right to use the VATSIM Network.

The person facing suspension will be given the opportunity to state their case before a ruling is passed and an official statement released to the member via email.

## 5 Rules, Rights and Obligations

### 5.1 Obligations

Every Moldova vACC member has the right to use Moldova vACC services and is obliged to comply with both the VATSIM Code of Conduct and Code of Regulations as well as local rules of conduct as specified in this document.

All members are obliged to maintain mutual consideration, esteem and respect for each other. Additionally, all members to ensure that their conduct does not preclude, detract or prejudice any other VATSIM members from making use of Moldova vACC, VATEUD, VATEUR or VATSIM services.

A member may be suspended from the use of all or some Moldova vACC services for a period of up to one calendar month if they are found to have violated any Moldova vACC rules (stated in this policy) or VATSIM rules (stated in the Code of Conduct and/or Code of Regulations).

## 5.2 Rules

Under section 5.2 of the Republic of Moldova vACC constitution, members are required to abide by the following set of rules:

- Follow the regulations set by Moldova vACC and its governing organisations of which it is under,
- Members must treat each other with respect and conduct themselves in a mature, dignified and professional manner at all times,
- Members should file all complaints to the vACC Director. This should be done confidentially and in a mature manner,
- Follow the Moldova vACC ATC Policy and regulations of Chisinau FIR Airspace

## 5.3 Rights

### 5.3.1 Members Rights

Under section 5.3.1 of the Republic of Moldova vACC constitution members are entitled to:

- Give ATC services within the Chisinau FIR airspace, after being signed off by one of the Moldova vACC approved examiners,
- Have fair and unbiased judgments placed upon them,
- Receive professional and appropriate ATC training by an approved Moldova vACC mentor upon request,
- Hold the appropriate ATC rating and validations based upon their competency and experience,
- Submit proposals for change, providing they would benefit Moldova vACC as a whole and not only the individual concerned,
- Apply to hold a Staff Position providing they meet the requirements stated in the "Staff Positions" document,
- Apply to become ATC mentors upon reaching a suitable level of ATC competency.

### 5.3.2 Staff Rights

Under section 5.3.2 of the Republic of Moldova vACC Constitution Staff hold the right to hold all the Rights stated in 5.3.1 in addition to the following:

- Remove members from the Moldova vACC, providing a unanimous verdict is reached
- Recommend members to either the vACC Director or Training Director for ATC rating upgrade subject to GRP requirements,
- Confront any members that they think that may be breaking Sections 5.1 and/or 5.2 of the Republic of Moldova vACC Constitution and report this to the vACC Director.
